

Statute

§ 1 Name, location and entry:

The association bears the name

Mary Magdalene Eritrean community in Germany (MMEG)

It has its seat in Frankfurt am Main. The Association shall be entered in the register . The fiscal year is the calendar year.

The Association may set up branches in other places in Germany.

§ 2 Purpose and Objective:

- advancement of religion
- Promotion of youth and the elderly
- Promoting international attitude , tolerance in all fields of culture and international understanding
- promotion of civic engagement for non-profit , charitable or church purposes.

§ 3 tasks (implementation of the objectives)

- cultural events such as concerts of church music and singing.
- Vulnerable persons who are in an emergency situation to help , selflessly.

- The establishment decoration and maintenance of houses of worship , holding of religious services, training of clergy , the issue of religious instruction , Beer- ending and the maintenance of memories of the dead as well as the management of the churches assets.

- Mitting (event) the summer camps and seminars on evaluation of the Basic Law , the spiritual and cultural order , and values of the entire POPULATION .

- The promotion of international attitude is achieved in particular through dialogue and exchanges between immigrants and locals. Here language barriers to be overcome by teaching similar assistance. In addition, an open exchange of different cultures takes place on the occasion of seminars and cultural events.

- The Youth Services is realized by various measures of child and youth care , through which a particular reference is made to promote the religion. These are , for example, Help with homework , play groups , painting groups , children singing together .

§ 4 profit

1 The association pursues exclusively and directly steuerbegünstigte purposes within the meaning of section tax-privileged purposes "of the fiscal code 1977.

2 Selflessness and remuneration of members: The Association is active , he is pursuing not intrinsically primarily economic purposes. Funds of the Association shall be reserved for the statutory purposes.

3 The members receive no benefits from the association .

4 Members may at their departure , upon dissolution or annulment of Association receive any shares of the association's assets .

5 No person may by issues that are related to the purpose of the association, or from disproportionately high remuneration paid out of proportion to Work are to be favored .

6 Board members receive a reimbursement of their expenses by stating their Expenses and presentation of the corresponding receipts.

7 A reclassification of the association's purpose can only with the consent of all members carried out . You need this personally specifications of the proposed Wrapping addressed in writing and within a notice period of six week To be asked to comment.

8 The club applied for membership in the German Joint Welfare Association (DPMV) .

§ 5 membership

1 Supporting members to both natural persons of any nationality without Regardless of ethnic origin, religion and gender, as well as legal People (clubs) that support the goals of the community. You do not have Voting rights but have access as members , and to all the services of the community receive inspection upon request in the annual financial report.

§ 6 membership

1 Applications for membership in the Association , in writing, to the Executive Board , which decides on the application for one month .

2 The Board confirmed the membership by sending a membership card and the current Vereissatzung.

3 Membership begins after admission with the payment of the contribution.

§ 7 membership fee

1 The level of membership is determined by the General Assembly .

2 The membership fee is in advance to the account of the Association or directly into the Payable club treasury . If you pay cash , a receipt is issued .

3 On prior request, the Board may , in justified cases, the payment of the Join limited contribution apart .

§ 8 Termination of Membership

1 Membership is terminated by death.

2 This exit must be made in writing to the Board . The explanation is the end of the calendar month effect , where it is received by the Board . theContribution shall be paid up to that point .

3 deletion

A member is removed by resolution of the Board from the membership list , if it is , despite at least two reminders to the payment of the premium for more than 12 months in arrears .

Members who are unknown warped and not appear within one year have also be deleted from the membership list .

4 exclusion

A member may be excluded if it against the statute and / or Association's interests grossly violates . The exclusion is under the Board of Management Stating the reasons the member by registered letter announced . For an Exclusion of a member is the right of opposition within 4 weeks after Delivery to the certificate. In case of differences , the General Assembly decides final.During the process of elimination to rest all the functions of the member , it is not entitled to then perform tasks for the club.

§ 10 General Assembly

1 Convening and conduct The General Assembly shall meet at listens once each calendar

year. It is convened by the Board at least four weeks before writing direct meeting date. The invitation is in the balance based on the current register of members .

An invitation will be deemed given when it is addressed to the last known address of the member .

2 The Board may also convene extraordinary general meetings

He must be convened if one third of the members so request in writing by the Board.

3 When writing to convene a meeting of the Executive Board Member Date ,

Specify the time and place and the agenda . Additional agenda items , that are desired by members , may , with the consent of the simple Majority of the members present to be treated.

4 Member meeting is not a public event. Speech and

Voting rights have only ordinary members.

5 Entitled to vote in accordance with this statute , those who no longer than three months with the Contributions in arrears .

6 Each member has one vote.

The General Assembly has a quorum if only at least half of the members. This fact is to bring Each invitation in writing to the members in memory.

Is in a duly convened general meeting the quorum is not reached, the Board is obliged to convene another General Assembly within five weeks. This is a quorum regardless of the number of members present. The Executive Board shall be pointed out in the invitation.

7 protocol

Minutes of each General Assembly is an attendance list and a record of results to lead . Timely Notice and Quorum , confirmation of the newly admitted members , name of the log management and name of the assembly line are each explicitly stated in the protocol. The agenda and the individual election results must also be included in the log. For amendments of the exact wording must be specified. The report must be signed by the log management and meeting management .

8 The General Assembly Rules of Procedure may provide .

§ 11 The request input

Proposals to the General Meeting must be received by the Board of Directors four weeks before Assembly ment time at the latest. You should goals and objectives of the organization relate to and promote the implementation and further development of the association.

§ 12 resolution

1 The General Assembly shall take decisions by a simple majority in the General of the valid votes .

2 Neutral vote disregarded Votes are usually caused by Show of hands , and on the request of the majority can also secretly by a Flyer be matched .

§ 13 Duties of the General Assembly

1 The General Assembly is the supreme body . It decides on all Affairs of the association , especially on the activities and priorities of the next year , on larger projects and plans that go beyond the normal duties of the office .

2 It monitors compliance with the statutory objectives of the Association and the financial management by the elected representatives / inside.

To this end , the Executive Bureau of the Assembly shall, at least once a year, submit an annual report and a financial report . The General Assembly relieved after reviewing the reports of his mind.

3 The General Assembly elects the Executive Board.

4 The General Assembly approves the inclusion of support members.

5 It also decides on the exclusion of members.

6 You decide the amount of the membership fee and the use of the Haushaltsmisaddles .To this end, the Executive Board shall submit annually to the Assembly a financial plan for the coming year .

7 She decides amendments and the resolution of the association.

§ 14 Amendments and dissolution of the Association

1 Amendments and dissolution of the Association shall be effective a resolution passed by two-thirds majority of the votes cast resolution of the General Assembly.

2 In this case , at least half of the members must be present. About an amendment may be adopted at the General Meeting only if advised that agenda already in the invitation. and at the same time both the previous session text and the proposed new session text were added .

§ 15 Board of Directors

1 The board of the association is elected by the Assembly for a period of two Selected years , however, until the election of a new board in office.
